1. Athletic Directors- Megan Coddington & Matt Harrod

- a. Starting Camps for various sports. 14 kids in a pod & 2 coaches. District will not let balls on campus yet. Hopefully equipment usage will be next week.
- b. NCS Rule; NO sports if AQI is 150 or above. 150-100 at coach's discretion
- c. Need Coaches for; JV Volleyball, V Wrestling, JV G Basketball & JV G Softball
- d. Sports Schedule; Many teams will be needing the field/track, Megan & Matt will be setting up a schedule to help keep it organized for all the teams.
- e. Participation Survey; 612 Students filled it out. Saw some low numbers, Girls Lacrosse had just 8 girls, Great information having numbers for the Spring sports, Helps with facility planning.
- f. Pixalot System; \$2500 to install, we need to see what the kids are doing out on the Main Field. Very hard to run the wiring. Campolindo spent \$4k rewiring. Can Boosters help pay for that?
